Janet E. Nash Dowdell, 93, died June 26 at Tidewell Hospice House in Bradenton. She was the daughter of the late Guy and Mildred Downer of Bradenton. Janet was predeceased by her husband, John Nash, father of her 3 children and James F. Dowdell, her second husband. She is survived by a daughter, Sandy Nash, of Palma Sola Harbour, a daughter, Kathy Snyder, a son, John Nash, 3 grandchildren, and 3 great grandchildren.

A Memorial Service was held at the PSH Clubhouse on July 12. Rev. Charles Tigard, Senior Pastor of Church of the Trinity presided, and Sandy's friend, Karen Greenley, was the soloist. The reception after the service was catered by Church of the Trinity.

Stanley Sladon, 60, died in Palma Sola where he lived as a caregiver for his mother, Sylvia Sladon. He is survived by Sylvia, 3 children, Natalie from New Orleans, Shiloh from Florida and Adam who lives in Oregon as well as a brother, Steven. **Clem & Annie Curtis** from Stowe, Vt. died 3 days apart on Sept. 7. Clem was 102 and Annie was two weeks shy of her 100th birthday. Clem died first while holding hands with Anne, his wife of 68 years. The obituary in their local paper was entitled "The end of a love story."

The youngest of 11 children, Clem discovered skiing as a very young child. He later became an accomplished ski jumper and performer touring with the Ice Capades and performing at Boston Garden and Madison Square Garden. During WW II, he taught skiing to the troops. Ever the entrepreneur, he owned several businesses and dealt in real estate as well as being an active member of the Stowe community. They retired to Florida when he was 72 where he enjoyed golfing and fishing. He is remembered for the twinkle in his eye and his dry sense of humor.

Anne was the youngest of 5. She taught elementary school and became principal of the school. She remained involved in education all her life. Her colleagues recalled her as ahead of her time in introducing remedial teaching techniques. She also kept the books for their numerous enterprises. Anne was active in her church and often the first to arrive with soup for anyone in need. She was an accomplished artist as well. She too loved to ski and was a volunteer ski instructor. They loved to entertain and travel, as well as playing bridge. Their 5 pm cocktail hour was sacred to them and it continued through their final days. "Annie" is remembered for her welcoming smile and gentle ways.

They are survived by their two children, Mary Skelton and Chris Curtis, grandchildren and numerous nieces and nephews.

Gladys Lewis, Donna Caldwell's mom, died July 8 at 94. In the late 70's when Gladys and Cec purchased their condo, PSH was an exciting place - primarily a retirement community. Wonderful friendships and a true sense of community made Palma Sola a special place that continues to this day through second generation families. Gladys loved hosting dinner parties as well as the fun times at the Rec Center. She learned to play golf and played regularly with the ladies. Gladys enjoyed volunteering at the flea market, social committee and as the Palma Sola Sunshine Lady! She loved her daily swims at the pool and walking the beach. Gladys was thrilled when her sister Irene retired close by. Most importantly, Gladys loved visits from family. She is survived by Donna Caldwell, Ken Lewis, three grandchildren and two great grandchildren.

William Stock, 70, died on July 18. Bill was born in S. Porcupine, Ontario. He lived in a number of different places in Canada before moving to a suburb of Chicago. Bill's love when he was growing up were horses and flying. From the time he was 15, he took flying lessons and got certified in everything he could. Bill finally managed to get his foot in the door at United Airlines and started his commercial flight training in Denver in 1964. That career lasted just over 30 years ending with flying 747's. He was involved with golf, quarter horses, race horses and boating for years but his true calling was flying. Bill and his wife Linda followed in his parents footsteps spending winters in PSH as does his sister Fran. He is greatly missed by his wife Linda, daughter Michelle, son Bill Jr., 4 granddaughters, a grandson, a great granddaughter, and his sisters Fran and Carol.

Document Committee - John Gardner

Twenty months ago a committee was appointed by the PSH Board of Directors to begin the complex task of revising the PSH governing Documents. These Documents (the Declaration and Bylaws) are the rules we are all required to comply with, as owners. Our current Documents were written about 45 years ago by the developer. Obviously, much has changed in our world and in our community since that time. This has left portions irrelevant or lacking the clarity for today's evolving issues and current interests of the community.

The primary goal of the Document Committee was to draft revised Documents that would provide us with a clear, fair and reasonable legal structure to guide our community in the present and future, while respecting each other's rights .

During these months, the Documents have been scrutinized countless times to incorporate clarifying language throughout, making it easier to understand and avoid misunderstandings. In addition, the first draft was sent to all owners for comment. The revised Documents incorporate community and Board preferences and suggestions.

A final draft has been presented to the Board. The Documents are now ready for the next phase of final review by outside counsel after which these revisions will again be presented to the Board for approval and then will be mailed to all owners for review and vote to adopt at a special meeting.

As committee members move through this final phase of the project I can't help but reflect on both the community and committee efforts during this long journey and I thank you all.
